

2018 ABINGTON HIGH SCHOOL MARCHING GHOSTS MEMBERSHIP AND FINANCIAL COMMITMENT AGREEMENT

Academic Eligibility: In order to maintain eligibility for membership in the Marching Ghosts, each member must remain in “good academic standing” as per the policy set forth in the Abington High School Student Handbook.

Attendance Eligibility: Each member is required to adhere to the High School Attendance Regulations as outlined in the Abington High School Student Handbook, as well as those set forth in the Abington Marching Ghosts Handbook.

Student Conduct: Each member is required to adhere to the policy outlined in the Abington Marching Ghosts Handbook and/or the Code of Conduct.

Financial Obligation: Each member **must earn 375*** non-refundable Marching Band Commitment Points for operational expenses. Commitment points are earned through participating in fundraising offered throughout the season and may be supplemented by direct payment. Statements will be issued monthly via email. A parent or student may request printed statements by contacting the Student Records Officer. One Point = One Dollar.

**This amount is based on an estimated number of participating students and forecasted expenses. There is a possibility of changes throughout the season. You will be notified immediately of any changes in the budget/commitment schedule.*

Any family that has a financial hardship must notify Mr. Detato in writing immediately but absolutely no later than 9/1/2018. Please note, members are still expected to participate in ALL fundraising.

Any student who has not earned the required Marching Band Commitment Points will not be eligible to attend the Annual Marching Band Awards Banquet, and may not be eligible to participate in the Indoor Program. **Also, the stunts will not be eligible for any scheduled trip.**

Any Commitment Points earned in excess of the required amount may be carried forward for the duration of the student's participation in the program, or can be used for a sibling participating in the program. The member may also choose to donate excess points to a fellow member.

Commitment payments may be made electronically directly from the monthly statement or they can be mailed to: Abington Band Boosters, Inc. PO Box 245, Abington, PA 19001. If a student chooses to pay by check during rehearsal the check **MUST** be in an envelope which designates the student's name.
